

## ARTICLES OF INCORPORATION OF.

ALZHEIMER'S RESOURCE CENTER OF LEE (a corporation not for profit)

95 MAY -2 PM 3: 50 We, the undersigned with other persons being desirous of forming a corporation not for profit. do agree to the following:

## ARTICLE 1 - NAME

The name of this corporation shall be ALZHEIMER'S RESOURCE CENTER OF LEE COUNTY, INC. The principal office address shall be 3595 Broadway, Fort Myers, Florida 33907. The duration of the corporation shall be perpetual.

## ARTICLE II - PURPOSE

The corporation is organized for charitable, educational, informational, and philanthropic purposes to assist persons with Alzheimer's disease and other dementia related disorders in need of social, health and human services. Activities shall include but not be limited to:

- n) providing information and referral services:
- b) providing central intake services:
- enhancing service coordination among providers of social health, and human services; c)
- d) providing support group services;
- developing resources to meet unmet social, health and human service needs; e)
- advocating on behalf of persons in need of social, health and human services; D
- providing public education on services available to meet health, social and human g) service needs; and
- providing training on available resources or issues concerning health, social and human h) service needs.

#### ARTICLE III - POWERS

The corporation shall have all powers provided for Corporations Not For Profit by Chapter 617.021 of Florida Statutes and including but not limited to the powers:

To receive and maintain a fund or funds of real or personal property, or both, and subject to the restrictions and limitations hereinafter set forth, to use and apply the whole or any part of the income there from and the principal thereof exclusively for the charitable, educational, informational, and philanthropic purposes described herein.

Nothing contained in the foregoing statement of purposes and powers shall be construed to authorize this corporation to carry on any activity for the profit of its members, or to distribute any gains, profits, or dividends to its members.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, any Director or Officer of the corporation or any member of the corporation or any other private individual (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes), and no Director or Officer of the corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.

The corporation shall distribute its income for each taxable year at such time and in such manner as not to become subject to tax on undistributed income imposed by Section 4942 of the

Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.

The corporation shall not engage in any act of self-dealing as defined on Section 4941(d) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.

The corporation shall not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.

The corporation shall not make any investments in such manner as to subject it to tax under Section 4944 of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.

The corporation shall not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws,

Notwithstanding any other provisions of these Articles of Incorporation, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from taxation under Section 501(c) (3) of the Internal Revenue Code and Regulations issued pursuant thereto as they now exist or as they may be eafter be amended, or by an organization, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code and said Regulations as they now exist or may be reafter be amended.

#### ARTICLE IV - OFFICERS

The officers of the corporation shall be a President, a Vice-President, a Secretary, and a Treasurer. Such officers will be elected annually as provided for in the by-laws.
