ARTICLES OF INCORPORATION OF THE CREATIVE WELLNESS INSTITUTE CORPORATION

The undersigned, acting as incorporator of a corporation under the non-profit Corporation Act of the State of Florida, adopt the following articles of incorporation.

ARTICLE I

The name of the corporation is The Creative Wellness Institute Corporation.

ARTICLE II
