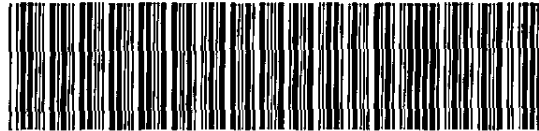



dissolution is November 30, 2005.


ADOPTION OF DISSOLUTION


