The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is: THE SOCIETY OF CHRISTIAN MISSIONARIES INC. The principle address of the corporation is: 575 Owosso Road, Lantana, Florida 33462.

ARTICLE TWO

The mailing address of this corporation shall be: 575 Owosso Road, Lantana, Florida 33462.

ARTICLE THREE

The purpose for which the corporation is organized is that of a fraternal benevolent religious society of non-denominational Christians. Established and maintained, not for profit, but to disseminate the Teachings of Jesus Christ and the Holy Scriptures, also referred to as "The Holy Bible". The manner in which the directors are elected or appointed is described in the by-laws of the corporation.


ARTICLE FIVE


