



1. "Article IX DISSOLUTION:

Upon dissolution of this Corporation, other than incident to a merger or consolidation, the assets of this Corporation shall be distributed either: (a) to the Members pursuant to a plan of distribution created pursuant to Chapter 617, <u>Florida Statutes</u>; or (b) as otherwise permitted by law.

The foregoing amendment has been adopted by a majority of the holders of the Membership Certificates of the Corporation, pursuant to a special shareholders meeting held on July 20, 2017, which vote was sufficient to approve the adoption of this Amendment.
