ARTICLES OF INCORPORATION

We, the undersigned, acting as incorporator(s) of a non-profit corporation pursuant to Section 617, Florida Statutes, adopt the following Articles of Incorporation, for such corporation.

ARTICLE I

The name of this corporation shall be and is ^{AKA} Christian Road Ministry ~~Inc~~ Corporation. The period of the duration of this corporation is perpetual, unless dissolved according to the law which allowed it's creation.

ARTICAL II

The principal address of this corporation shall be: 4802 Richardson Road, Crestview, Fl., 32639.

ARTICLE III

This corporation (CRM CORP.) is organized exclusively for educational, charitable, religious, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law). This Corporation being a non-profit entity will have no substantial part of the activities or shall the corporation be the carrying on of propaganda, or otherwise attempting to influence legislation (except as provided by law), and the corporation shall not participate, or intervene in, including the publishing or distribution of statements in any political campaign on the behalf of any candidate for public office. The following specific purpose defines the general nature of the ministry or activities to be transacted by this corporation:

1. To glorify our Lord and Savior Jesus Christ by serving as His instrument in declaring and spreading His truth. Principles included in God's truth are:

a. The Holy Bible, the Old and New Testaments, to be the inspired Word of God, without error in the original writings. God's doctrine concerning the historical and scientific facts are infallible, this also applies to His moral and spiritual teachings, the revelation of His will for the salvation of man by His Grace, and is also the Divine and final authority for all Christian faith.

b. There is but one true living GOD, creator of all things, infinitely perfect and eternally existing in three persons: God the Father, God the only begotten Son, and God the Holy Ghost.

c. The Lord Jesus Christ is truly God, became man without ceasing to be God. He was conceived by the Holy Ghost and born of the Virgin Mary. He died on the cross a sacrifice for our sins according to the Scripture. Believers are redeemed by the blood of Jesus Christ. Further, He rose bodily from the dead, ascended into Heaven, where at the right hand of the Holy God on high He is seated as our High Priest and Advocate.

d. The Ministry of the Holy Ghost, according to the Scripture, is to glorify the Lord Jesus Christ, and to convict sinners of the world of their sins. He is the supernatural agent in regeneration, indwelling, guiding, and sanctification. He baptizes all believers into the body of Christ. He is the Divine Teacher who guides believers into all truth.

e. Man was created in the image of God, but Adam sinned and the entire human race fell, inherited a sinful nature, became alienated from GOD, and is utterly unable to remedy his lost condition. Therefore, lost and only through regeneration by the Holy Spirit can salvation and spiritual life be obtained. Those who accept it by faith with a contrite heart, apart from works, become new creatures in Christ.

f. The shed blood of Jesus Christ and His resurrection which provide the only grounds for justification and salvation for all who believe. Only those who believe Jesus Christ is Savior and Lord are born again (regenerated) of the Holy Ghost and thus become children of God.

g. Each believer possesses a new nature and at least one spiritual gift for the edification of the body of Christ; and therefore should be a faithful steward of all that God has entrusted to him.

h. All believers are to observe the ordinances of our Lord Jesus Christ, water baptism and the Lord's Supper. They are, however, not to be regarded as means of salvation.

i. The education of children is the responsibility of the parents rather than the State. God commands parents to teach their children to love God and do all things to His glory. The School is an instrument of God designed to help the parents faithfully discharge their responsibility.

j. The fear of God is the beginning of knowledge. Wisdom and knowledge are His. True Christian knowledge must be consistent with Scripture, and inspired by the Holy Ghost. Man must learn to discover God's truth. The school can assist by providing a God-centered curriculum and encouraging academic excellence.

2. The C R M Corp., The Christian Road (Community) Church, and The Christian Road Bible College will conduct no activity inconsistent with the above principles. Activities in God's truth will include:

a. To teach/engage in and promote Christian Discipleship as commanded by Jesus Christ in the Great Commission.

b. To Christianly educate children and adults in the philosophy of God from the Old Testament, the doctrine of Jesus Christ from the New Testament, and provide services normally associated with Christian Churches and Schools.

c. To act as agent or representative of CRM Corporation to firms, or individuals organized, located, or residing in any part of the world in Christian Education.

d. To purchase or otherwise receive the assets of any other corporation or ministry organized for similar purposes.

e. To enter into, make, perform, and to carry out contracts and agreements of every kind for any lawful purpose without limit as to amount with any person(s), firm, association, or corporation and to carry out any additional transactions as necessary which is or may be connected with the purpose of this corporation or calculated to facilitate the same.

f. To carry on any or all of its operations and ministries and to promote its objects within the State of Florida or elsewhere without restriction as to place or amount, use/exercise, and enjoy all of the general powers of like corporations.

g. To do any or all of the things herein set forth to the same extent as natural persons might or could do in any part of the world as principals, agents, contractors, or otherwise alone or in company with others, and do and perform all such other things and acts as may be necessary, profitable or expedient in carrying on any of the ministry or acts above named.

ARTICLE IV *directors*

The qualifications for members, ^{and} the manner of their admission are specified in the bylaws.

ARTICLE VII

- A. The corporation is organized under a closed non-stock basis.
- B. No provision of these articles of corporation are intended to be inconsistent with law regarding the regulation of internal affairs of the corporation, including, without limitation, any provision with respect to the relative rights or interests of the member as among themselves or in the property of the corporation.

ARTICLE VIII

In the event of demise of the C R M CORP., the residual assets, real, and tangible holdings of this corporation will be released, turned over, transferred to one or more organizations which themselves having made contribution to this corporation and are exempt as organizations described in section 501(c)(3) and 170 (c) of the Internal Revenue Code of 1986 (or corresponding sections of any future Internal Revenue Code), as the Board of Directors shall determine.

ARTICLE IX

The affairs of this corporation will be managed by the Board of Directors, who, subject to the provisions of the Articles of Incorporation, the Bylaws, and the laws of the State of Florida, shall hold office until their successors are elected and have qualified. The Directors of the Corporation shall be the entire voting power of the Corporation.

ARTICLE X

These Articles of Incorporation and the By-Laws for "The-G-R-M-CORP." *Christian Road Ministry Corporation* maybe made, altered, or rescinded by the Board of Directors only, and by at least a three forth (3/4) majority vote. The Constitution and By-Laws of the "Christian Road (Community) Church", "Christian Road Bible College", and "Christian Road Real Estate and Cemetery" maybe made, altered, or changed as stated in the Article of their By-Laws, and submitted by the Board of Trustee's to the Board of Directors for their review, recommendation and or retention.

ARTICLE XI

The Board of Directors will delegate the executive authority to operate the programs and facilities of this corporation to The Agent/CEO of CRM CORP. The Bishop of The Christian Road (Community) Church, The Superintendent of Operation for the Church Cemetery and overall real estate, and The Dean of The Christian Road Bible College will have operation authority as provided in the by-laws.

ARTICLE XII

Subject to the provisions of the Statutes of the State of Florida, the Board of Directors' meeting may be held at any time or place designated by the CEO or Executive Committee as prescribed by the Bylaws, either within or without the State of Florida, and this corporation may have an office/offices to keep the books of the corporation outside the State of Florida.

ARTICLE XIII

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by (a) A corporation exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) A corporation contributions to which are deductible under section 170(c) of the Internal Revenue Code of 1954 (or any other corresponding provision of any future United States Internal Revenue Law).
