The undersigned, for the purpose of forming a non-profit corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

ARTICLE ONE

CORPORATE DURATION:

The duration of the Corporation is perpetual, unless dissolved according to law. The Corporate existence shall commence upon the date of subscription and acknowledgment (Notarization).

ARTICLE THREE

PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are: Educational and charitable, more particularly;

1. To lesseri neighborhood tension; eliminate discrimination, and combat deterioration, by expanding the opportunities available to members of minorities and low income groups, to improve themselves economically, to own, manage, operate and be employed in business enterprises; to further the development of locally operated business enterprises in economically underprivileged or depressed areas; to assist members of minority and low income groups and developing entrepreneurial and management skills necessary for the successful investment in or operation of business enterprises; and to assist members of such underprivileged groups in obtaining adequate financial support, education and training for the successful investment, ownership, management and operations and business enterprises.
