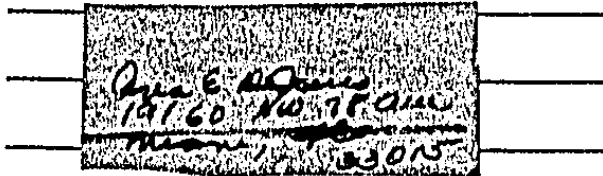

The undersigned, acting as founders and incorporators of a corporation, and pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation for said corporation on Dec. 15, 1994, in Miami, Dade County, Florida.

Article I

The name of this church shall be, Tabernaculo de Adoracion, Inc. (or Worship Tabernacle, Inc.) its' primary location at: 19160 N.W. 67th Ave., Miami, Florida.

Article II

The purposes for which this corporation is organized is:

- To preach and teach the Gospel of our Lord Jesus Christ, and bring glory to His name; this according to the interpretations set forth in the By-laws of this corporation..
- To incorporate other churches into our fellowship and corporation
- To ordain ministers, as necessary.

Article III

The duration of this corporation will be perpetual and indeterminate; unless dissolved by its' President and its' Board of Directors.

Article IV

The Registered Agent for this corporation will be: Ana E. De Jesus, living at 19160 N.W. 78th Ave., Miami, Florida, 33015.

Article V

This corporation is organized under a non-stock basis.

Article VI

The qualifications for membership, its' inherent rights, and responsibilities and all pertinent matters shall be defined in the By-laws of this corporation.

Article VII

The names and addresses of the members of the initial Board of Directors , who will hold office for the first year are:

The Board of Directors will be elected and appointed each year upon recommendations from the Church's governing bodies, (Pastor, Elders, Deacons, Church Ministries) and will be recognized by the congregation at an annual meeting.

Article VIII

This corporation will be directed and administered by the Pastor of the church, who may also be the President of the Corporation. The Pastor will designate a Ministerial Body to assist with the spiritual and administrative aspects of the church. Such body will consist of:

Body of Elders
Body of Deacons
Body of Church Ministries

Article IX

This corporation authorizes its' President to serve as administrator for finances, make deposits, write checks, along with designated co-signature. If the President is not the Pastor, he will recommend to the Pastor actions on all pertinent aspects of the Ministry for final approval by the Pastor.

Article X

In the event of dissolution, the residual assets of the corporation will be turned over to one or more organizations which themselves possess exempt status as described in Sec. 501-C-3 and 170-C-3 of the Internal Revenue Code of 1954, or corresponding sections of any prior or future law, or to the Federal, State, or Local government for exclusive public purposes.
