CERTIFICATE OF INCORPORATION

OF

JACKSONVILLE BEACHES LIONS CLUB, INC

A Florida Nonprofit Corporation

THIS IS A NONPROFIT CORPORATION ORGANIZED SOLELY FOR GENERAL CHARITABLE PURPOSES PURSUANT TO THE FLORIDA NOT FOR PROFIT CORPORATION ACT.

ARTICLE I

THE NAME OF THE CORPORATION SHALL BE: JACKSONVILLE BEACHES LIONS CLUB, INC.

ARTICLE II

- A. THE SPECIFIC AND PRIMARY PURPOSES FOR WHICH THIS CORPORATION IS FORMED ARE TO OPERATE FOR THE ADVANCEMENT OF EDUCATIONAL AND CHARITABLE PURPOSES, BY THE DISTRIBUTION OF ITS FUNDS FOR SUCH PURPOSES. THE GENERAL NATURE OF THE BUSINESS TO BE TRANSACTED BY THIS CORPORATION IS AS FOLLOWS:
- B. THE GENERAL PURPOSES FOR WHICH THIS CORPORATION IS FORMED ARE TO OPERATE EXCLUSIVELY FOR SUCH EDUCATIONAL AND CHARITABLE PURPOSES AS WILL QUALIFY IT AS AN EXEMPT ORGANIZATION UNDER SECTION 501(c)(3) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED, OR CORRESPONDING PROVISIONS OF ANY SUBSEQUENT FEDERAL TAX LAWS, INCLUDING, FOR SUCH PURPOSES, THE MAKING OF DISTRIBUTIONS

TO ORGANIZATIONS WHICH QUALIFY AS TAX-EXEMPT ORGANIZATIONS UNDER THAT CODE.

C. THIS CORPORATION SHALL NOT, AS A SUBSTANTIAL PART OF ITS ACTIVITIES, CARRY ON PROPAGANDA OR OTHERWISE ATTEMPT TO INFLUENCE LEGISLATION; NOR SHALL IT PARTICIPATE OR INTERVENE (BY PUBLICATION OR DISTRIBUTION OF ANY STATEMENTS OR OTHERWISE) IN ANY POLITICAL CAMPAIGN ON BEHALF OF ANY CANDIDATE FOR PUBLIC OFFICE, NOR SHALL IT CARRY ON ANY OTHER ACTIVITIES NOT PERMITTED TO BE CARRIED ON BY THE LAWS OF THE STATE OF FLORIDA OR BY A CORPORATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501(c)(3) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED, OR CORRESPONDING PROVISIONS OF ANY SUBSEQUENT FEDERAL TAX LAWS.

ARTICLE III

THIS CORPORATION SHALL HAVE PERPETUAL EXISTENCE.

ARTICLE IV

THE PROPERTY OF THIS CORPORATION IS IRREVOCABLY DEDICATED TO EDUCATIONAL AND CHARITABLE PURPOSES, AND NO PART OF THE NET INCOME OR ASSETS SHALL EVER INURE TO THE BENEFIT OF ANY DIRECTOR, OFFICER, OR MEMBER THEREOF, OR TO THE BENEFIT OF ANY PRIVATE INDIVIDUAL, EXCEPT THAT THE CORPORATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED.

ARTICLE V

THE CORPORATION SHALL HAVE A MEMBERSHIP DISTINCT FROM THE

BOARD OF DIRECTORS. ANY PERSON PAYING DUES AS PROVIDED FOR IN THE BYLAWS AND AGREEING TO BE BOUND BY THE ARTICLES OF INCORPORATION OF THIS CORPORATION, BY ITS BYLAWS, AND BY SUCH RULES AND REGULATIONS AS THE DIRECTORS MAY FROM TIME TO TIME ADOPT, IS ELIGIBLE FOR MEMBERSHIP IN THE CORPORATION. THE DIRECTORS SHALL FROM TIME TO TIME PRESCRIBE THE FORM AND MANNER IN WHICH APPLICATION MAY BE MADE FOR MEMBERSHIP.

THE POWER OF THIS CORPORATION SHALL BE EXERCISED, ITS PROPERTIES CONTROLLED, AND ITS AFFAIRS CONDUCTED BY A BOARD OF DIRECTORS. THE NUMBER OF DIRECTORS SHALL NOT BE LESS THAN THREE. THE METHOD OF ELECTING DIRECTORS SHALL BE STATED IN THE BYLAWS.

ANY CERTIFICATES OR OTHER DOCUMENT FILED UNDER ANY PROVISION OF LAW WHICH RELATES TO ACTION SO TAKEN SHALL STATE THAT THE ACTION WAS SO TAKEN BY UNANIMOUS WRITTEN CONSENT OF THE BOARD OF DIRECTORS WITHOUT A MEETING AND THAT THE ARTICLES OF INCORPORATION AND BYLAWS OF THIS CORPORATION AUTHORIZE THE DIRECTORS TO SO ACT. SUCH A STATEMENT SHALL BE PRIMA FACIE EVIDENCE OF SUCH AUTHORITY.

ARTICLE XI

THE BUSINESS OF THIS CORPORATION SHALL BE CONDUCTED BY A PRESIDENT, ONE OR MORE VICE-PRESIDENTS, A SECRETARY AND A TREASURER, AND SUCH ASSISTANTS AS THE BOARD OF DIRECTORS MAY FROM TIME TO TIME PROVIDE FOR. THE METHOD OF ELECTION OF OFFICERS SHALL BE STATED IN THE BYLAWS. THIS CORPORATION MAY PRESCRIBE AND MAKE SUCH OTHER PROVISIONS BY PROPER BY-LAWS AS THE CORPORATION MAY DESIRE FOR THE REGULATION OF THE BUSINESS AND FOR THE CONDUCT OF THE AFFAIRS OF THE CORPORATION, AND ANY PROVISION CREATING, DIVIDING, LIMITING, AND REGULATING THE POWERS OF THE CORPORATION, THE DIRECTORS AND STOCKHOLDERS; PROVIDED SUCH PROVISIONS ARE NOT CONTRARY TO THE LAWS OF THE STATE OF FLORIDA.

SUBJECT TO THE LIMITATIONS CONTAINED IN THE BYLAWS, ANY LIMITATIONS SET FORTH IN THE CORPORATIONS NOT FOR PROFIT LAW OF FLORIDA CONCERNING CORPORATE ACTION THAT MUST BE AUTHORIZED OR APPROVED BY THE MEMBERS OF THE CORPORATION, BYLAWS OF THIS CORPORATION MAY BE MADE, ALTERED, RESCINDED, ADDED TO, OR NEW BYLAWS MAY BE ADOPTED, EITHER BY A RESOLUTION OF THE BOARD OF DIRECTORS OR BY FOLLOWING THE PROCEDURES AS SET FORTH THEREFOR IN THE BYLAWS.

ARTICLE XIII

UPON THE DISSOLUTION OR WINDING UP OF THIS CORPORATION, ITS ASSETS REMAINING AFTER PAYMENT, OR PROVISION FOR PAYMENT, OF ALL DEBTS AND LIABILITIES OF THE CORPORATION, SHALL BE DISTRIBUTED TO A NONPROFIT FUND, FOUNDATION, OR CORPORATION WHICH IS EXCLUSIVELY ORGANIZED AND OPERATED FOR CHARITABLE PURPOSES AND WHICH HAS ESTABLISHED ITS TAX EXEMPT STATUS UNDER SECTION 501(e)(3) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED, OR CORRESPONDING PROVISIONS OF ANY SUBSEQUENT FEDERAL TAX LAWS.

ARTICLE XIV

AMENDMENTS TO THESE ARTICLES OF INCORPORATION MAY BE PROPOSED BY A RESOLUTION ADOPTED BY THE BOARD OF DIRECTORS AND PRESENTED TO A QUORUM OF THE MEMBERS FOR THEIR VOTE. AMENDMENTS MAY BE ADOPTED BY A TWO-THIRDS VOTE OF A QUORUM OF MEMBERS OF

THE CORPORATION. NO AMENDMENT SHALL BE ALLOWED WHICH WOULD IMPAIR THE NONPROFIT OR TAX EXEMPT STATUS OF THE CORPORATION.

ARTICLE XV

NOTWITHSTANDING ANYTHING TO THE CONTRARY IN THESE ARTICLES OF INCORPORATION OR THE BYLAWS, THE CORPORATION WILL BE SUBORDINATE TO AND SUBJECT TO THE AUTHORITY OF THE INTERNATIONAL ASSOCIATION OF LIONS CLUBS, ITS RULES, REGULATIONS AND BYLAWS, AND ANY SUCH CONFLICTING PROVISIONS SHALL BE NULL AND VOID AND THE INTERNATIONAL CONSTITUTION AND BYLAWS SHALL GOVERN IN SO FAR AS THE SAME ARE LAWFUL AND NOT IN CONFLICT WITH ANY LAWS OF THE STATE OF FLORIDA OR THE UNITED STATES OF AMERICA.
