ARTICLES OF INCORPORATION  
OF  
BALLET FOLKLORICO ISTMEÑO - RECUERDOS DE MI PANAMA, INC.

We, the undersigned incorporators, hereby associate ourselves and make, subscribe, acknowledge and file with the Secretary of State of Florida these Articles of Incorporation for the purposes of forming a Corporation Non-Profit pursuant to Chapter 617 of the Florida State Statutes.

ARTICLE I - NAME AND GEOGRAPHIC AREA

The name of this corporation is BALLET FOLKLORICO ISTMEÑO - RECUERDOS DE MI PANAMA, INC.

The headquarters of this corporation shall be in the state of Florida within the central part of the State.

ARTICLE II - PURPOSES AND OBJECTIVES

This entity is organized and shall be operated exclusively as a non-profit corporation under Chapter 617 of the Florida Statutes, which uses the goals and methods and other disciplines to secure and exhibit the Panamanian culture, such as the music, dance, costumes, and folklore, but not limited to, in the United States of America and particularly in Central Florida.

Its purpose is to provide seminars, shows of our folklore, music, dance, and other characteristic manners and habits of the Isthmus of Panama.

The income of the corporation shall not be unreasonably accumulated or reinvested in such a manner as to jeopardize the carrying out of the purposes of the corporation.

This corporation is organized for the purpose of transacting any or all lawful business of which non-profit corporations may be incorporated as now exists or may be amended.

ARTICLE III - POWERS

This corporation shall be authorized to exercise the powers permitted to non-profit corporations.

ARTICLE IV - MEMBERSHIP

The membership of this corporation shall constitute all persons hereinafter names as officers and directors and such other persons of good moral character from time to time may become members by a majority vote of the Board of Directors.

ARTICLE V - TERM OF EXISTENCE

This corporation shall have perpetual existence.

#### ARTICLE VII - LOCATION AND PRINCIPAL OFFICE

The principal office of this corporation shall be located at 2421 Bonnevillie Dr., Orlando, FL 32826.

#### ARTICLE VIII - INITIAL REGISTERED OFFICE AND AGENT

The initial registered agent of this corporation shall be Rafael Armien, at the principal office address listed above.

#### ARTICLE IX - OFFICERS AND DIRECTORS

The affairs of this corporation shall be managed by a Board of Directors as provided in the By-laws, provided however that all members of the Board of Directors must also be members of the corporation.

#### ARTICLE X - MANAGEMENT OF CORPORATION AFFAIRS

Board of Directors - The power of this corporation shall be exercised, its properties controlled, its affairs conducted and its business managed by a Board of Directors. The number of Directors shall initially be four (4), and the number of Directors may be increased from time to time by the By-laws, but shall never be less than three (3). Directors shall be elected by the members of the corporation from the membership at annual meeting of the membership. The Directors of the corporation must, at all times, be members of the corporation. The names and addresses of the persons who are to serve as Directors for the ensuing year, or until the first annual meeting, of the corporation are:

Other officers must be Directors of the corporation, provided however that one or more assistant secretaries may be elected by the Directors, and such person or persons need not be Directors of the corporation.

#### ARTICLE XII - DISSOLUTION

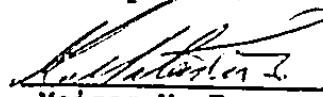
