ARTICLES OF INCORPORATION
LaBRIE MINISTRIES INCORPORATED
(A Florida Non-profit Corporation)

ARTICLE I

A. The name of the corporation shall be LaBRIE MINISTRIES INCORPORATED (hereinafter referred to as the "Corporation").

B. The initial date of Corporate existence is the date of filing of these Articles.

ARTICLE II

A. The purposes for which the Corporation is organized are as follows:

1. To operate and act exclusively for charitable and educational purposes.

2. The Corporation will accomplish the following goals: To provide Christian ministry and services of any nature whatsoever as an outreach from, or ministry to the Body of Christ, Christian individuals, and Christian ministries wherever situate.

3. To generate, receive and administer assets exclusively for charitable and educational purposes.

4. To conduct any and all activities and exercise any and all such powers for which a Florida Corporation may be organized and such as are necessary to the achievement of the foregoing and in furtherance of the purposes of the Corporation.

B. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activity not permitted to

be carried on (a) by an organization exempt from Federal income tax under section 501 (c)(3) of the Internal Revenue Code of 1984, as amended (the "Code"), or corresponding provisions of any subsequent Federal tax laws.

C. No substantial part of the activities of the Corporation shall be to carry on propaganda or otherwise attempt to influence legislation.

ARTICLE III

A. The Corporation is organized on a nonstock basis.

B. The Corporation is organized on a membership basis.

1. There shall be two classes of Members of the Corporation which shall be: Class I, subscribing churches and individuals; Class II, subscribing ministries and individuals.

2. Class I Subscribing churches and individuals shall be those who pledge and provide financial support by donation to the ministries of the Corporation, in accordance with standards set by the Board of Directors in their by-laws.

3. Class II Subscribing ministries and individuals shall be those Christian ministries and individuals who contract and pay for low-cost music studio services, including video or audio recording, payment of such costs being made to the Corporation, according to standards set by the Board of Directors in their by-laws.

4. Member churches and individuals shall at all times have the right to request Evangelistic services, and they shall be provided as time permits.

5. Membership in the Corporation shall cease upon expiration of any twelve month period in which no financial contributions are given to the Corporation by Class I members, or upon failure to pay for services by Class II members.

C. The assets which the Corporation possesses are:

Real property: none.

Personal property: none.

D. The Corporation is to be financed by gifts, grants and contributions from Class I member churches, individuals, businesses and other organizations according to their ability and willingness to contribute; and payments made by Class II members for services rendered to them by the Corporation.

ARTICLE IV

ARTICLE VI

ARTICLE VII

The term of the Corporation's existence is perpetual unless dissolved by the Board of Directors.

ARTICLE VIII

A. No part of the net income of the corporation shall be distributed to, or inure to the benefit of, any director or officer of the Corporation, contributor, or private person. Gross income shall be used to pay salary to ministers and staff, and operating expenses of the Corporation. Net income remaining after payment of salaries and operating expenses shall be utilized according to the direction of the Board of Directors, but only in keeping with the purposes of the corporation and regulations governing a Non-profit Corporation.

B. In the event of the dissolution of the Corporation, all of the Corporation's assets, real and personal, shall be distributed to such charitable organization or organizations qualified as tax-exempt under section 501 (c)(3) of the Code or corresponding provisions of any subsequent Federal income tax laws, as the Board of Directors of the Corporation shall

determine. Any such assets not so disposed of, for whatever reason, shall be disposed of by Order of the Court, to such organization or organizations as the Court shall determine are organized and operated exclusively for charitable purposes.

C. In the event the Corporation is determined to be a "private foundation" as that term is defined in Code section 509 (a), then for the purpose of complying with the requirements of Code section 508 (e), for all taxable years commencing on or after January 1, 1984, the Corporation shall:

1. Distribute its income and such part of capital as may be required by law for each taxable year at such time and in such manner as not to become subject to tax on the undistributed income imposed by Code section 4942, or corresponding provisions of any subsequent Federal tax laws;

2. Not engage in any act of self-dealing as defined in Code section 4941, or corresponding provisions of any subsequent Federal tax laws;

3. Not retain any excess business holdings as defined in Code Section 4943, or corresponding provisions of any subsequent Federal tax laws;

4. Not make any investments in such manner as to subject it to tax under Code Section 4944, or corresponding provision of any subsequent Federal tax laws;


5. Not make any taxable expenditures as defined in Code Section 4945, or corresponding provisions of subsequent Federal tax laws.

ARTICLE IX

A. The Board of Directors shall promulgate with power to amend, by-laws for the Corporation.

B. The Articles of Incorporation may be amended in any manner consistent with applicable law; provided however, that no Amendment to these Articles of Incorporation shall be effective unless and until the same has been approved by the Board of Directors of the Corporation.

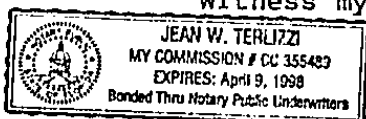


