ARTICLES OF INCORPORATION
OF

SERENITY VILLAGE, INC.

A FLORIDA CORPORATION

ARTICLE ONE

NAME

The complete legal name of the corporation is Serenity Village, Inc.

ARTICLE TWO

DURATION

The term of existence of the Corporation is perpetual. The corporate existence will commence on the filing of these articles by the Department of State.

ARTICLE THREE

PURPOSE

The purpose for which the Corporation is organized is to supply shelter for the homeless and for the purpose of recovery for drug abuse and alcoholics anonymous.

REGISTERED OFFICE AND AGENT

ARTICLE SIX

MEMBERS

The Corporation shall have Members. Members of the Corporation will be required to meet one of the following qualifications:

1. Be in an alcoholics anonymous program;
2. Be in a drug abuse program;
3. Be homeless.

Persons meeting these qualifications will be admitted for a period of thirty (30) days to six months from referrals by the following facilities:

1. CARE (detox center)
2. Women's crisis center
3. Probation department
4. Jail
5. Court


