OF  
NEIGHBORHOOD ALIANCE ORGANIZATION, INC.  
(A Not For Profit Corporation)

I.

NAME

The name of this corporation shall be NEIGHBORHOOD ALIANCE ORGANIZATION, INC., and the principal office of said corporation is as follows: 235 W. Brandon Blvd., Suite 187, Brandon, FL 33511.

II.

PURPOSE

This corporation is organized to engage in any activity of business permitted under the laws of the United States or of this state. This corporation is organized pursuant to FL Statute Section 617 et al., and the purpose of this corporation is to provide food for hungry children throughout the United States.

III.

TERM OF EXISTENCE

This corporation shall begin existence upon the filing of these Articles of Incorporation, and shall exist perpetually.

IV.

PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
