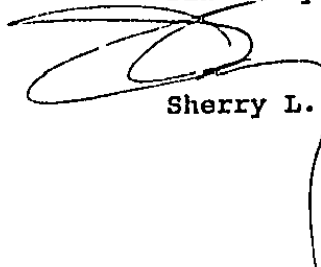

ARTICLES OF INCORPORATION  
OF  
TARIMA SCHOOL OF THE ARTS, INC.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be: TARIMA SCHOOL OF THE ARTS, INC.

The corporate powers of this corporation are as provided in Section 617.0302, Florida Statutes, unless limited as follows: The corporate power are not limited.

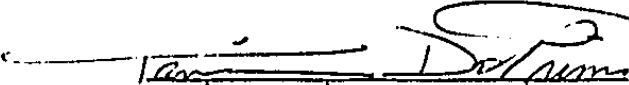
