ARTICLES OF INCORPORATION

FOR

THE
MILLENIUM OF GLORY EVANGELICAL CHURCH INC.

The undersigned, acting as Incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

THE MILLENIUM OF GLORY EVANGELICAL CHURCH INCORPORATED

ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be:

ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):

For the more certain preservation and security of the faith which was once delivered to the saints, and to the end that this body may be governed in an orderly fashion consistent with the written Word of God, and for the purpose of bringing all men and women back to the true Judaeo-Christian heritage inherent in the scriptures, and that men and women, boys and girls might know our blessed Saviour and Lord, Jesus Christ, we do declare and establish this corporation.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows:

THE PASTOR

The Pastor shall be appointed by a council elected by the laity. A quorum being 'necessary while a simple majority may carry the vote. The Pastor's tenure may not be terminated once elected.

OFFICERS OF ORDINANCE (Deacons)
Elected by council, and renewed yearly by council vote.

MINISTERS OF FINANCE
Elected by council, and renewed yearly by council vote.
Amendments and addendums contained in the church's by-laws.

ARTICLE V LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 817.0302, Florida Statutes, unless limited as follows:

Pastoral recommendation with council approval governs the church. All other officers serve the body but do not exercise governing authority. They, and indeed the entire church, are subject to Pastoral and council policy and polity.
