CHARTER OF ST. JOHN'S ACADEMY PRIVATE SCHOOL, INC.

A NON-PROFIT ELEEMOSYNARY CORPORATION

ARTICLE I. NAME

The name of this corporation shall be ST. JOHN'S ACADEMY PRIVATE SCHOOL, INC.

ARTICLE II. GEOGRAPHIC AREA OF OPERATION

The geographic area of operation of this corporation shall be St. Johns County, Florida.

ARTICLE III. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of this Charter by the Secretary of State of Florida. This corporation's duration shall be perpetual.

ARTICLE IV. PURPOSE

Section 1 - <u>Purpose</u>. This corporation is being organized to establish, maintain, promote, and operate a Christian school which is charitable, religious/educational, and which may make distributions to organizations under 501(c)(3) of the Internal Revenue code of 1954 (or any amendment thereof).

Section 2 - Mission. The mission is "To provide a Christ-centered and Classical education" for the children of Ponte Vedra Beach and surrounding areas.

ARTICLE V. POWERS AND LIMITATIONS

Section 1 - Powers. This corporation shall be empowered to engage in the transaction of any and all activities permitted under the "Private School Corporation Law of 1959," Chapter 623, Florida Statutes. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article.

Section 2 - <u>Limitations on Activities</u>. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the Corporation shall not participate in , or intervene in any political campaign on behalf of any candidate for public office.

Section 3 - Activities Limited by Tax Code. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from forderal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or any amendment thereof) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or any amendment thereof).

Section 4 - No Loans. No loan shall be made by the Corporation to any officer or director.

Section 5 - <u>Dissolution</u>. Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the Corporation, dispose of all the assets of the Corporation exclusively for the purposes of the Corporation in such manner, or to such organization(s) organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954 (or any amendment therof) as the Board of Directors shall determine.

ARTICLE VI. OUALIFICATIONS OF MEMBERS AND MANNER OF DESIGNATION

Section 1 - <u>Charter Members</u>. The qualifications of the Charter members named hereinafter are that each member is over the age of eighteen (18) years of age and is a legal resident of the County of St. Johns, State of Florida.

Section 2 - <u>Members</u>. The Corporation shall have members. Qualifications for members shall be set forth in the Corporation's Bylaws.

Section 3 - Voting by Members. Voting by members shall be limited to (1) approval or disapproval of nominations for election by the Board of Directors to the position of Director and (2) approval or disapproval of proposals for enactment by the Directors of changes to the Charter or Bylaws. No vote of members for these purposes shall be required prior to the Corporation's

first acquiring legal title to real estate.
