OF
BETHEL SCHOOL COMMUNITY CENTER, INC.

a Non-Profit Corporation

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopt the following articles of incorporation for such corporation.

ARTICLE I - NAME

The name of the Corporation is BETHEL SCHOOL COMMUNITY CENTER, INC.

ARTICLE II - DURATION AND PRINCIPAL ADDRESS

The period of duration of the corporation is perpetual. The principal address is Route 2, State Road 149, Monticello, Florida 32344.

ARTICLE III - PURPOSE

The purpose or purposes for which the corporation is organized are to engage in providing community services including recreation, art, crafts, public meeting facilities, youth and family activities and other functions and activities serving the community , and to own or lease real property to carry out these purposes.


ARTICLE VIII - INDEMNIFICATION
