**ARTICLES OF INCORPORATION OF  
MERRITT ISLAND LASSIE LEAGUE SOFTBALL, INC.**

(A Corporation Not for Profit)

I, the undersigned resident of the State of Florida, being eighteen (18) or more years of age, do hereby associate myself for the purpose of forming a corporation not for profit, under the laws of the State of Florida, pursuant to the following Articles of Incorporation:

**ARTICLE I**

**Name**

Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.
