ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation shall be:

MYTILENE ASSOCIATION OF FLORIDA "SAINT RAPHAEL", INC.

The principal place of business of this corporation shall be: 3890 LAKE SHORE DRIVE, PALM HARBOR, FLORIDA 34684.

The mailing address of this corporation shall be:
3890 LAKE SHORE DRIVE, PLAM HARBOR, FLORIDA 34684.

ARTICLE II

The period of the duration of this corporation is perpetual unless dissolved according to law and the existence of this corporation shall commence with the filing with the Secretary of State.

ARTICLE III

The purpose for which the corporation is organized is to provide organization to promote the Greek culture and provide for the welfare and education of people of the Greek heritage.

ARTICLE IV

The qualifications for members and the manner of their admission are provided for in the ByLaws.

ARTICLE V

The manner in which the directors are appointed or elected is provided for in the Bylaws.


