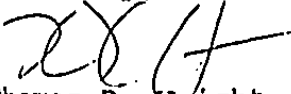

The undersigned heroby files these Articles for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, privileges and immunities of a corporation for not for profit.

**A R T I C L E   I**  
**NAME**

The name of this corporation shall be **NATIONAL COMMUNICATIONS OFFICERS ASSOCIATION, INC.**

**A R T I C L E   II**  
**DURATION**

This corporation shall exist perpetually unless sooner terminated in accordance with law; and the corporate existence will commence on the filing of these Articles by the Department of State.

**A R T I C L E   III**  
**PURPOSE**

Pursuant to Section 501(c)(3) of the Internal Revenue Code, the corporation is organized and operated exclusively for the purpose of promoting the professional education and development of public safety emergency communications agencies and public employees affiliated therewith. No part of the corporation's net earnings will inure to the benefit of or be distributed to the shareholders, directors or officers, who shall not be entitled to share in the distribution of the corporation's assets on dissolution of the corporation. The corporation will not, as a substantial part of its activities, attempt to influence legislation.

The corporation will distribute its income for each tax year at such time and in such manner so that it will not become subject to the tax on undistributed income imposed by Section 4942 of the Internal Revenue Code, or corresponding provisions of any later federal tax laws.

The corporation will not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code, or corresponding provisions of any later federal tax laws.

The corporation will not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code, or corresponding provisions of any later federal tax laws.

The corporation will not make any investments in a manner that would subject it to tax under Section 4944 of the Internal Revenue Code, or corresponding provisions of any later federal tax laws.

The corporation will not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code, or corresponding provisions of any later federal tax laws.

**A R T I C L E   I V**  
**PRINCIPAL PLACE OF BUSINESS**  
**INITIAL REGISTERED OFFICE AND AGENT**

The principal place of business and general office of this corporation will be 3528 South Atlantic Avenue, New Smyrna Beach, Volusia County, Florida 32169, but it may maintain offices and transact business at such other places, either within or outside the State of Florida, as the Board of Directors may from time to time provide by resolution. 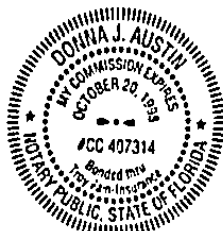

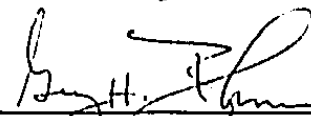
