## ARTICLES OF INCORPORATION OF

A Florida Not-For-Profit Corporation of Pinellas County, Florida

### ARTICLE 1

The name of this corporation is Asian Mutual Assistance Association Inc.

## ARTICLE 2 PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall

### ARTICLE 3 PURPOSE

The specific purposes of this corporation are follows: to establish a mutual relationship among Asians by rendering to all members the assistance and help upon their death as stated; to provide education, cultural, social service and community social activities to insure cultural preservation and promote community development of Asian individuals and families which will enhance successful participation in the greater community.

## ARTICLE 4 MANNER OF ELECTION OF DIRECTORS

Directors shall be elected by the Members at the annual meeting of Members, and shall serve until the next succeeding annual meeting, and until their successors have elected and qualified.

### ARTICLE 5

The Corporation shall have Voting Members, who shall be elected (and may be removed) by the Voting Members, and who shall have all the rights and privileges of members of the Corporation. The Bylaws may provide for Nonvoting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws, but who shall not have the right to vote.
