## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

CHRIST AID, INC., under its corporate seal in the hands of its duly elected President and Director, Wayne Tucker and Jeff Chamberlain, respectively, herby certify that:

The members of the said corporation, at a meeting called for said purpose on the 17<sup>th</sup> day of February, 2009 and after notice as required, adopted the following resolutions:

BE IT RESOLVED by the members of CHRIST AID, INC., that said members deem and hereby declare it to be advisable that the Charter of Articles of Incorporation of said corporation be amended, changed and altered to read in its entirety, through all Articles thereof, as follows:

### ARTICLES OF INCORPORATION OF CHRIST AID, INC.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation not for profit under the laws of Florida.

#### ARTICLE I

**NAME** 

The name of this corporation is Christ Aid, Inc.

#### **ARTICLE II**

#### **ENABLING LAW**

This is a non-profit corporation, organized solely for general religious, charitable, and educational purposes pursuant to the Florida Corporation Not For Profit Law set forth in Section 617 of the Florida Statutes.

#### ARTICLE III

#### **PURPOSE**

The general nature of the business to be transacted by this corporation and the purpose for which it is organized is to own, hold, manage, lease, mortgage, pledge and otherwise handle and dispose of such real estate and personal property as shall be authorized and directed by the Board of Directors of Christ Aid Inc. a Titusville, Florida "Christian Charitable" Organization.

The specific and primary purposes for which this corporation is formed are:

- A) To provide shelter and food to persons, children, and families with a holistic Christian program of discipleship.
- B) To cooperate with and support other charitable organizations interested in the ministry to those in need.
- C) To communicate the Gospel of Jesus Christ through the words and actions of its members and volunteers.

This corporation is organized exclusively for charitable, education, training, religious or scientific purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax codes).

This corporation is organized and operated exclusively for non-profit purposes and no part of any net earnings shall inure to the benefit of any member, director, or officer.

Notwithstanding any other provision of the Articles, the corporation shall not carry on any other activities not permitted (a) by a corporation exempt from Federal income tax under Section 501 (c)(3) of the Internal Revenue Code (or corresponding section of any future tax code).

#### **ARTICLE IV**

The term for which this corporation shall exist shall be perpetual.

#### ARTICLE V

#### ARTICLE VI

#### **BOARD OF DIRECTORS**

The powers of this corporation shall be exercised, its properties controlled, and it affairs controlled by a board of three minimum (3) and a maximum of 12 (12) directors as determined by the setting Board Members.

The board of directors shall only act as a unit. No individual board member may exercise control or commit the organization in any manner.

The board of directors shall employ an Operations Director who shall be responsible for the daily operations of Christ Aid Inc. Employment shall be by majority vote of all board members. Any and all compensation shall be decided by majority vote of the Board of Directors.

The Board of Directors shall make and approve By-Laws to govern the corporation. Approval shall be by majority vote of board members.

The Board of Directors shall approve policies and procedures written to direct the daily operations of Christ Aid Inc.

The Board of Directors shall meet each month, unless otherwise agreed to by the board, to review operations and plans. The Secretary shall keep minutes of the meetings as official documents of the organization.

#### ARTICLE VII

#### DISOLUTION

Upon dissolution of the corporation, the Board of Directors shall, after paying and making provisions for the payment of all the liabilities of the corporation, dispose of all the assets of the corporation to another organization or organizations which are organized and operated for the same purpose for which this corporation is organized or to such organization or organizations operated for charitable, educational, religious, literary or scientific purposes as shall at that time qualify as an exempt organization or organizations under Section 501 (c)(3) Internal Revenue Code of 1954.(or corresponding section of any future tax code). Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the country in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### ARTICLE VIII

#### AMENDMENTS

The Board of Directors shall adopt and amendments to the Articles of Incorporation. Adoption of an amendment shall require a majority vote if there are four (4) directors or by a majority plus one (1) if there are more than 4 directors.

#### ARTICLE IX

#### **BY-LAWS**

By-Laws shall be constituted, or amended by the Board of Directors at a meeting called for this purpose. Presentation of new or amended by-laws shall be provided to each member of the Board of Directors at least one (1) week prior to voting. Approval shall be by the majority of the Board of Directors. In accordance with By-Laws, policies and procedures shall by developed by the Director of Operations and approved by the Board of Directors by a majority vote of the Board of Directors.

#### ARTICLE X

#### OFFICE; IDENTIFICATION OF REGISTERED AGENT
