ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I

Name

ARTICLE III

Purpose(s)

The specific purpose(s) for which the corporation is organized is(are):

Southern Star Ministry Inc. is a non-profit church, preaching the gospel to a fallen world, reaching out to those in need as resources and abilities dictate. It is primarily a voluntary organization to be of service to the surrounding community. Southern Star Ministry Inc will seek to work with children, visit the sick and elderly, conduct worship services, conduct weddings, funerals, baptisms, special celebration as the need arises, along with all other church related activities.

ARTICLE IV

Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

Following Biblical Standards the offices to be held in Southern Star Ministry Inc are the following: Bishop, Pastor, Deacon, Deaconess. These positions will be filled by the process of ordination & Licensing as the need develops. All of these positions are open to men and women of solid Christian character with the approval of the Bishop(s). Functions and Duties of these offices will vary according to need. Bishops and pastors are recognized by Southern Star Ministry Inc as ordained clergy with full authority to fulfill all ministerial duties such as weddings. Deacons and Deaconess are licensed positions and their duties are determined by the Presiding Bishop(s) through the Pastor, according to need.

ARTICLE V

Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited are as follows:

The Presiding Bishop(s) shall have full responsibility and authority to oversee and direct the day to day operations of Southern Star Minister Inc. The presiding Bishop(s) shall have full authority to appoint and remove individuals especially if they should bring discredit upon The Name of Jesus Christ or The Name of Southern Star Ministry Inc. This includes revoking Ministerial Credentials and Licenses.
