# CHARTER

## OR

# ARTICLES OF INCORPORATION

OF
EL SINAI CHURCH, ASSEMBLIES OF GOD INC.
IGLESIA EL SINAI, ASAMBLEA DE DIOS, INC.
(NOT FOR PROFIT)

We, the undersigned persons of the state of Florida, all of whom are of legal age, each being competent to contract, hereby form ourselves and our successors into a corporation not for profit under the Laws of the State of Florida, and hereby adopt the following Articles of Incorporation:

### ARTICLE 1 - NAME

The name of this Corporation shall be: Illesia El Sinai, Asamblea de Dios, Inc.

Florida, with its principal place of business located at 4670 Lipscomb St., Sto 16, Palm Bay, FL 32905

Brevard County, Florida. The name of this Corporation's initial registered agent is Rev. Luis F.

Lugo and his address is 1404 Dowse Ct. N.E., Palm Bay, FL 32905

#### ARTICLE 11 - PURPOSE

The general nature, object and purpose of this corporation is as follows:

A. To establish and maintain a place for the worship of Almighty God, our Heavenly Father to provide for Christian fellowship for those of like precious faith, were the Holy Ghost may be honored according to our distinctive testimony; to assume our share of responsibility and the privilege of propagating the gospel of Jesus Christ by all available means, both at home and abroad.

B. To perpetuate, promulgate, and support the doctrines of the General Council of the Assemblies of God, and it, and all its property, both real and personal, shall be subject to the lawa, usage's and ministerial appointments of the General Council of the Assemblies of God, Springfield, Missouri, and the Southeastern Spanish District Council of the Assemblies of God, as are now or shall be from time to time established, made, and declared by the lawful authority of the said Councils.

#### ARTICLE HI - PROPERTY

The Corporation shall have the power to buy, acquire, and hold title in fee simple, in trust, or otherwise, to both real and personal property, and improve, encumber, sell, convey and dispose of all such property, to borrow money, execute notes, bonds, and other evidences of indebtedness and to secure the same by mortgages and deeds of trust, annuity bond, and other instruments of indebtedness and to pay interest thereon, to improve, adapt, and use property held by it for: The said Church Corporation or the income therefrom in the religious, educational, benevolent, or social activities of the: said corporation or its successor without financial profit to its members

except as may be necessary in the payment of salaries, or other compensation for services rendered, and the corporation shall have the power to crect and maintain buildings to be utilized by the said church, for the worship of God, for the training in Christian faith, and to build and maintain residences for the use and occupancy of the ministers of said Church Corporation, in conformity with the hy-laws of said corporation and all the power a right granted to Corporations Not for Profit under the laws of the State of Florida.

#### ARTICLE IV - MEMBERSHIP

The members of the corporation shall be all members in good standing at any given time of the said Church Corporation of Florida. Provides, however, neither the incorporates nor the members of the corporation shall have any vestedright, interest, or privilege of, in or to the assets, functions, affairs or franchises of this corporation, or any right, interest of privilege which may be inheritable, or shall continue after his membership ceases in the forenamed corporation. The corporation shall not have the power to ay, mortgage, sell encumber of deed or dispose of any property which it may acquire, without the consent or the direction of a two-thirds (2/3) majority vote of the members, or its successor.

### ARTICLE-V - TERM

This corporation shall exist perpetually or until dissolved by due process of the law. Should this corporation ceases to exist as a legal entity and its charter be terminated, title to all its property automatically shall become vested in the Southeastern Spanish District Council of the Assemblies of God, Inc. in the same manner as it holds title to any other property.
