**ARTICLE OF INCORPORATION
OF
KIWANIS CLUB OF WESTSIDE RIVIERA BEACH, INC.**

The undersigned, acting as incorporator of a corporation not for profit pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation of such corporation.

ARTICLE I

The name of this corporation shall be Kiwanis Club of Westside Riviera Beach, Inc. The mailing address of corporation shall be:

ARTICLE II

The existence of this corporation shall be perpetual.

ARTICLE III

The purposes of the Kiwanis Club of Westside Riviera Beach are:

1. To give primacy to the human and spiritual rather than to the material values of life.
2. To encourage the daily living of the Golden Rule in all human relationships.
3. To promote the adoption and application of higher social, business and professional standards.
4. To develop, by precept and example, a more intelligent, aggressive, and serviceable citizenship.
5. To provide through this club, a practical means to form enduring friendships, to render altruistic service, and to build better communities.
6. To cooperate in creating and maintaining that sound public opinion and high idealism which makes possible the increase of righteousness, justice, patriotism, and goodwill.
7. For the purpose aforesaid, to take over the assets, rights and franchises of the unincorporated club, known as the Kiwanis Club of Westside Riviera Beach, and its members.
8. To do all such things as are incidental or conducive to the attainment of the above objects.

ARTICLE IV

The qualifications of members and the manner of their admission shall be in accordance with the provisions set forth in the Bylaws.

ARTICLE V

The Board of Directors shall consist of all elected officers and five additional elected directors. Election of officers and directors shall be in accordance with the corporation Bylaws. The names and addresses of the initial Board of Directors are:

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section (c) (4) of the Internal Revenue Code or any corresponding sections of any prior or future law, or to the federal, state, or local government for exclusive public purpose.

ARTICLE VIII

These Article may be amended by a two-thirds vote of the membership of the Corporation at a duly noticed meeting.


