ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 817, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation shall be:

NATIONAL ASSOCIATION OF NAPERAPATHIC PHYSICIANS, INC.

ARTICLE II

ARTICLE III

A.

Purpose(s)

The specific purpose(s) for which the corporation is organized is(are): To enhance and upgrade the educational, professional, literary, fraternal, scientific, non-political standards of "hands on" body work therapists, therapeutic touch healing art practitioners, Homeopathic physicians, Naprapathic Physicians, Neuropathic physicians, mechano-therapists, herbalists, iridologists, ortho-molecular therapists, chelation therapists, neuromuscular integration therapists, food and vitamin therapists, clinical ecology therapists, eclectic natural healing art practitioners.

B.

To form our own board of examiners for testing, registration, recognition, certification of practitioners not presently defined by statutes of the state of Florida and the various other states, territories, and dominions of the United States.

ARTICLE IV

Manner of election of directors

The manner in which the directors are elected or appointed is as follows: The directors shall be composed of not less than three nor more than twenty-five persons and may be fixed at the annual meeting of the members of the corporation in the manner specified in such by-laws, insofar as is practicable the terms of office of the initial directors shall be staggered so that one third of such terms shall expire at the end of each of the first, second, and third years. Thereafter the terms of each director shall be for a period of three years.

ARTICLE IV, INSERT # 1 CONTINUED

A.

The business of the corporation shall be under the overall supervision of chairman Randall Lee McArthur, M.D., Ph.D., by-laws of the corporation are to be made, altered or recinded only by the chairman.

B.

The by-laws may provide for the appointment of an executive committee, such committee to exercise all or part of the powers by authority of the Board of Directors.

C.

The meeting of the Board of Directors and the membership shall be at such times as set forth in the by-laws.

D.

Amendment of the articles of the corporation shall be approved in writing by the chairman of the corporation.

E.

The corporation shall neither have or exercise any power, nor shall it engage directly or indirectly in any activity that would invalidate its status as a corporation.

F.

No part of the net earnings of the corporation shall be to the benefit of or distributed to its members, directors, officers, or other private person, except that the corporation shall authorize and empower to pay reasonable compensation for services rendered and to make payment and distribution in furtherence of the purposes set forth in article three.

G.

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all liabilities of the corporation, distribute all assets of the corporation, exclusively for the purposes of the corporation in such manner, or to such organizations organized for charitable, educational, or scientific purposes that shall at the time qualify as an organization described in section 501 (c) (3) of the Internal Revenue code of 1954, as the Board of Directors shall determine .

ARTICLE V

Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited are as follows:
