

#### ARTICLE I NAME

The name of this corporation is: BUCK RIDGE II OWNERS ASSOCIATION, INC.

#### ARTICLE II EXISTENCE

Existence of the Association shall commence with the filing of these Articles of Incorporation with the Secretary of State, Tallahassee, Florida. The Association shall exist in perpetuity.

# PURPOSE AND POWERS OF THE ASSOCIATION
