WE, THE UNDERSIGNED INCORPORATORS, PURSUANT TO CHAPTER 617 FLORIDA STATUES, HEREBY ASSOCIATE OURSELVES WITH AND ESTABLISH A CORPORATION NOT FOR PROFIT UNDER SAID LAWS OF THE STATE OF FLORIDA.
