ARTICLES OF INCORPORATION

WE, THE UNDERSIGNED INCORPORATORS, PURSUANT TO CHAPTER 617,
FLORIDA STATUTES, HEREBY ASSOCIATE OURSELVES WITH AND
ESTABLISH A CORPORATION NOT FOR PROFIT UNDER SAID LAWS OF THE
STATE OF FLORIDA.

ARTICLE I

THE NAME OF THE CORPORATION SHALL BE:

THE SOUTHWEST VOLUSIA CULTURAL ARTS AND HISTORICAL SOCIETY INC.

ARTICLE II

THE LOCATION OF BUSINESS IN THIS STATE WILL BE:

THE PRINCIPAL OFFICE WILL BE:

ARTICLE IV

THE SPECIFIC PURPOSE(S) OF THIS CORPORATION WILL BE:

THIS CORPORATION IS ORGANIZED NOT FOR PROFIT UNDER THE LAWS
OF THE STATE OF FLORIDA, AND THE OBJECT AND PURPOSE ARE TO
CREATE DISPLAYS OF MEMORABILIA DEPICTING THE ACTIVITIES THAT
TOOK PLACE DURING THE SCHOOL DAYS OF MANY OF THE MINORITY
LEADERS IN AND AROUND THE WEST VOLUSIA AREA; THROUGH THE USE
OF ANY AND ALL DOCUMENTS, PHOTOGRAPHS, AND OTHERS MATERIALS
THAT WOULD MARK ANY OUTSTANDING ACHIEVEMENTS BY MINORITY
INDIVIDUALS THAT ATTENDED AREA SCHOOLS IN THE WEST VOLUSIA
AREA. BY DISPLAYING THESE ITEMS IN A CULTURAL SETTING, IT IS
HOPED THAT THE MINORITY YOUTH OF THE WEST VOLUSIA AREA WILL
BE INSPIRED AND TO BENEFIT FROM SOME OF THE POSITIVE
ACHIEVEMENTS THAT AREA LEADERS HAVE MADE IN THE COMMUNITY.

ARTICLE V

THE MANAGEMENT OF THE CORPORATION SHALL BE:

THE BUSINESS OF THIS CORPORATION SHALL BE MANAGED BY A BOARD OF DIRECTORS CONSISTING OF MEMBERS OF THE CORPORATION. THE NAMES BELOW INDICATE THE BOARD FOR THE FIRST ENSUING YEAR OF OPERATION UNTIL THE FIRST ANNUAL MEETING IS HELD. The manner of election of the directors shall be as provided in the bylaws.
