ARTICLES OF INCORPORATION OF  
CONCERNED CITIZENS OF FORT MYERS BEACH, INC.

The undersigned incorporators execute these articles of incorporation for the purpose of forming and do hereby form a nonprofit corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be: Concerned Citizens of Fort Myers Beach, Inc.

ARTICLE II PRINCIPAL PLACE OF BUSINESS & MAILING ADDRESS

The principal place of business and the mailing address of the corporation shall be:

156 Ibis Street, Fort Myers Beach, Florida 33931.

ARTICLE III PURPOSES

(A) The corporation is organized and operated exclusively for educational and civic purposes. In carrying out its corporate purposes, the corporation shall have all the powers allowed corporations by the Florida Statutes.

(B) In furtherance of the general purposes in paragraph (A), the particular purposes of the corporation are:

To educate the residents of Fort Myers Beach, Florida on issues of concern.

#### ARTICLE IV DIRECTORS

The business and affairs of the corporation shall be governed by a board of directors. The three members of the initial board of directors shall serve until the first annual election of directors and until their successors are elected and qualify. A director may be removed from office by a majority vote of the members, with or without cause. DIRECTORS SHALL BE ELECTED AS PROVIDED IN THE CORPORATE BYLAWS.


