The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, <u>Florida Statutes</u>, adopts the following Articles of Incorporation of such corporation:

#### ARTICLE I

The name of the corporation shall be ARNOLD & ADWINA BAPTISTE MINISTRIES, INC., and the proposed place of business shall be 5103 Cochita Dr., Orlando, FL 32808.

#### ARTICLE\_II

The period of the duration of this corporation shall be perpetual, unless dissolved according to law.
