**ARTICLES OF INCORPORATION
OF
DA & A FINANCIAL SERVICES CORP.
A FLORIDA NOT-FOR-PROFIT CORPORATION**

Article I: Name. The name of the Corporation shall be DA & A Financial Services Corp..

Article II: Duration. The duration of the Corporation is perpetual.

Article III: Purposes. The purpose of the corporation is as follows:

A. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. Said corporation is organized exclusively for charitable purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code.

B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporation under the Internal Revenue Code and no part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its stated purposes.

D. The corporation shall not engage in any activities for the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

E. Notwithstanding any other provision of these articles, the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Article IV: Initial Registered Agent and Office. Initial registered agent is Anne D. Pargament and the initial registered office 9106 Bearcat Rd., New Port Richey, Florida.

Article V: Initial Board of Directors. The initial Board of Directors shall have 3 members whose names and addresses are:

The Bylaws shall provide the method of election of all Directors, and the number of Directors may be raised or lowered by amendment of the bylaws but shall in no case be less than three.

Article VI: The officers of the Corporation shall consist of a President, Vice President, Secretary, and Treasurer. Other officers may be provided for in the Bylaws. Each Officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such time and in such manner as may be prescribed by the Bylaws. The names and addresses of the initial Officers of the Corporation are as follows:

Article VII: Incorporators. The incorporator of this corporation is Anne D. Pargament whose street address is 9106 Bearcat Rd., NPR, FL 34655.

Article VIII: Nonstock Basis. The Corporation is organized (and shall be operated) on a nonstock basis within the meaning of the Florida Not For Profit Corporation Act, and shall not have the power to issue shares of any type or class of stock.

Article IX: Dissolution of Corporation. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article X: Corporate Address. The street address of the Corporation's initial principle office is 9106 Bearcat Rd., New Port Richey, FL 34655 and the Corporation's mailing address is 7143 SR 54, Suite 172, New Port Richey, FL 34653.
