#### ARTICLES OF INCORPORATION

FOR

#### THESSALONIAN CHURCH OF GOD,

INC.

I.

THE NAME OF THE CORPORATION IS THESSALONIAN CHURCH OF GOD, INC.

II.

THE CORPORATION IS ORGANIZED PURSUANT TO THE PROVISIONS OF THE FLORIDA NON-PROFIT CORPORATION CODE.

III.

THE CORPORATION SHALL HAVE PERPETUAL DURATION.

IV.

THIS CHURCH SHALL BE ORGANIZED AND OPERATED EXCUSIVELY FOR RELIGIOUS PURPOSE WITHIN THE MEANING OF SECTION 501(c) (3) OF THE INTERNAL REVENUE CODE OF 1990, OR THE CORRESPONDING PROVISION OF ANY FUTURE UNITED STATES INTERNAL REVENUE LAW, THAT DOES NOT DIRECTLY CONFLICT WITH OUR BELIEFS AND DOCTRINE, AS SET FORTH IN THE KING JAMES VERSION OF THE HOLY BIBLE, IN ORDER TO:

- 1.MINISTER THE WORD OF GOD
- 2.CONDUCT A REGULAR WORSHIP SERVICE THROUGH VARIOUS FORMS OF MINISTRIES.
- 3.PROMOTE AND ENCOURAGE, THROUGH THE MINISTRIES THE ORGANIZATIONS MINISTERING WITHIN THE COMMUNITY.
- 4.SPREAD THE WORD OF THE GOSPEL BY MINISTERING TO ALL THROUGH SEMINARS, RADIO, TELEVISION, AND OTHER FORMS OF MASS MEDIA.
- 5.TO CONDUCT A LOCAL AND INTERNATIONAL CHURCH BY DIRECTION OF THE LORD JESUS CHRIST AND UNDER THE LEADERSHIP OF THE HOLY SPIRIT IN ACCORDANCE WITH ALL THE PROVISIONS AS SET FORTH IN THE HOLY BIBLE.
  - 6.TO MAINTAIN LOCAL CHURCH AND MISSIONARY FACILITIES.
  - 7.TO CONDUCT A SCHOOL FOR TRAINING MINISTRIES.
  - 8.TO LICENSE AND ORDAIN QUALIFIED INDIVIDUALS.



9.TO PROVIDE SAINTS SCHOOL OR ANY TYPE OF SCHOOL FOR RELIGIOUS AND EDUCATIONAL INSTRUCTION OF THE YOUNG, AS WELL AS FOR ADULTS UNDER THE DIRECTION OF THE CHURCH.

10.TO ENGAGE IN ANY LAWFUL BUSINESS, ACT OR ACTIVITY RELATED THERETO AND FOR WHICH CORPORATIONS MAY BE ORGANIZED UNDER THE FLORIDA NON-PROFIT CORPORATION CODE.

#### V.

THESSALONIAN CHURCH OF GOD IS NOT ORGANIZED, NOR SHALL IT OPERATE FOR PECUNIARY GAIN OR PROFIT, AND IT DOES NOT CONTEMPLATE THE DISTRIBUTION OF GAINS, PROFITS, OR DIVIDENDS TO ITS MEMBERS AND IS ORGANIZED SOLELY FOR NON-PROFIT PURPOSES.

THE PROPERTY, ASSESTS, PROFITS AND NET INCOME OF THIS CHURCH ARE IRREVOCABLY DEDICATED TO CHARITABLE, EDUCATIONAL AND RELIGIOUS PURPOSES AND NO PART OF THE PROFITS OR NET INCOME OF THIS CHURCH SHALL EVER INURE TO THE BENEFITS OF ANY PROFIT SHAREHOLDER OR INDIVIDUAL, ON THE DISSOLUTION OR WINDING UP THIS CHURCH, ITS ASSESTS REMAINING AFTER PAYMENT OF ALL DEBTS AND LIABILITIES OF THIS CORPORATION SHALL DISTRIBUTED TO A RELIGIOUS ORGANIZATION, FOUNDATION, OR CORPORATION THAT IS ORGANIZED AND OPERATED FOR CHARITABLE ECCLESIATICAL RELIGIOUS, OR SACREDOTAL PURPOSES.

DIRECTORS SHALL BE ELECTED/APPOINTED AS PROVIDED FOR IN THE CONSTITUTION AND BY-LAWS OF THE CORPORATION.
