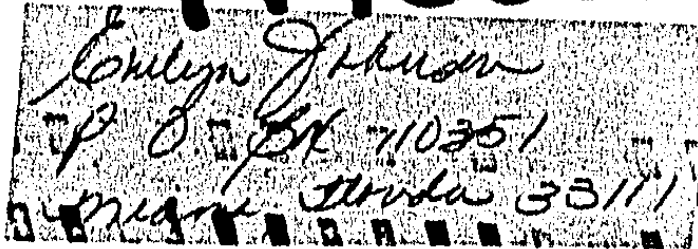

ARTICLES OF INCORPORATION

OF

ARMOR BEARER'S FOR CHRIST MINISTRY, INC.

(A CORPORATION NOT-FOR-PROFIT)

KNOW ALL MEN BY THESE PRESENT, that the undersigned, do hereby associate ourselves together for the purpose of forming a not-for-profit religious society/corporation under the laws of the State of Florida, and do hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of this corporation is:

Armor Bearer's For Christ Ministry, Inc.

ARTICLE II

TERM OF EXISTENCE

This Corporation shall have perpetual existence unless sooner dissolved according to law.

ARTICLE III

PURPOSE

The general nature of the object of this corporation shall be;

(a) To teach, preach and proclaim; promulgate and promote the tenets and philosophy of Christianity;

(b) To ordain and license members to preach Christianity according to the beliefs of this Church;

(c) To encourage lectures on all subjects pertaining to the spiritual and secular welfare of mankind;

(d) To advocate and promote spiritual healing and to protect and encourage spiritual teachers in all laudable efforts in giving evidence or proof to mankind of a continued relationship between mankind and his Creator (THE LORD JESUS CHRIST);

(e) To teach and proclaim that a correct understanding of such expression and living in accordance therewith constitutes true religion;

(f) To teach and proclaim that the highest morality is contained in the Golden Rule, "Whatsoever ye would that men should do to you, do ye also to them";

(g) To teach and proclaim that we affirm the moral responsibility of the individual and that he makes his own happiness or unhappiness as he obeys or disobeys the Word of God;

(h) To teach and proclaim that the doorway to reformation is never closed against any human soul;

(i) To teach and proclaim that the practice of prophecy as authorized in the Holy Bible is a Divine and God-given gift;

(j) The acquisition of title to real estate, either by purchase; gift; lease, or otherwise, as owner in fee simple, or lessee, for use for religious purposes;

(k) To buy; own; hold; contract; improve; mortgage; lease; sell; convey, or otherwise acquire and dispose of real, personal, or mixed property, or any right; interest or estate therein, as owners or otherwise;

(l) To construct, build, or repair; maintain; operate or lease such buildings or other improvements or property owned or contracted by the corporation;

(m) To borrow money and contract debts when necessary for the exercising of the corporation rights, privileges or franchises, or for any other lawful purpose of its incorporation; to issue bonds; personal notes; bills of exchange; debentures and other obligations and evidence of indebtedness, payable at a specific event or events, whether secured by mortgage, pledge, or otherwise, or unsecured for money borrowed or in payment for property purchased or acquired or for any lawful object or objects.

ARTICLE IV

BY-LAWS

(a) The By-laws of the corporation shall be adopted by the Board of Directors. The power to alter, amend, or repeal the bylaws or to adopt new bylaw shall be vested in the Board of Directors. The bylaws may contain any provisions for the regulation and management of the corporation not inconsistent with the Corporation Laws of the State of Florida or of these Articles of Incorporation.

ARTICLE VII

MANAGEMENT

The Board of Directors shall adopt such dues, fees and assessments in connection with the admission of non-permanent members, as they may determine from time to time to be necessary to continue the operation of said religious society.

ARTICLE VIII

The highest amount of indebtedness or liability to which this corporation may, at any time, subject itself, which shall never be greater than two-thirds (2/3) of the value of the corporation, in any event.

ARTICLE IX

AMENDMENTS

These Articles of Incorporation may be amended from time to time by a majority vote of the Board of Directors, as approved by the President, Evelyn Johnson.

IN WITNESS WHEREOF, we have made, signed and accepted this Certificate of Incorporation and proposed Charter, this 28 day of APRIL, 1995.

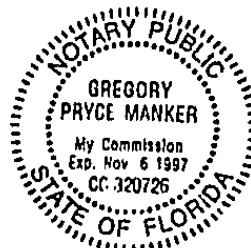


