**Articles of Incorporation of the
Central Florida

We, the undersigned subscribers of these Articles of Incorporation, each a natural person competent to contract, do hereby associate ourselves together for the purpose of forming a corporation not for profit under the laws of the State of Florida, and to that end do hereby certify the facts set forth as required by law.

ARTICLE I

Name

The name of this corporation is Central Florida International Food Service Executive's Association, Inc.

ARTICLE III

Purposes

The general nature of the business to be transacted by this corporation is the advancement of the interests and welfare of its members and the advancement of the interests of their employers in every honorable way; the uplifting of the standards and dignity of the members' position by education and training them in the varied requirements of their profession, and in the education and training of their employees in their various food service establishments; and the advancement of the interests of the organization in the State of Florida and the City of Orlando.

ARTICLE IV

Qualification and Manner of Election

The officers of this corporation shall be, but not limited to, a President, a First Vice President, a Second Vice President, a Recording Secretary, and a Treasurer, who shall have the general control and management of the business affairs, property and funds of the corporation,

elected by the majority of votes at the annual meeting held on the second Tuesday in September of each year for a term of one (1) year, commencing on the second Tuesday in October of each year. Board of Directors will be elected as stated within the Branch Bylaws.

ARTICLE V

Qualification and Manner of Member Admission

The qualification for membership shall be established from time to time in the By-Laws of the corporation. The Manner of admission shall be by application in writing upon forms prescribed by the Executive Board of the corporation and governed by International Food Service Executive's Association - National Headquarters.

ARTICLE VI

Term

This corporation shall have perpetual existence.

ARTICLE VII

By-laws and amendments to the By-Laws shall be adopted at two consecutive monthly meetings of the membership by an affirmative vote of two-thirds (2/3) of the members present and voting at each meeting.
