ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation shall be: **TEAM NEARFALL, INC.**

ARTICLE II

Principal place of business and mailing address

The principal place of business and mailing address of this corporation shall be: 3336 50th Avenue Court East, Bradenton, Florida 34203.

ARTICLE III

Purpose

The specific purposes for which the corporation is organized are: To promote, develop and increase the skills of young athletes in amateur wrestling for preschool, grade school, high school, college, Olympic, regional, national and international competition.




