ARTICLE OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is: AMERICAN INFORMATION DATA SERVICES, INC. The principle address of the corporation is: 2488 Lona Lano, W. Palm Beach, Florida 33415-7288.

ARTICLE TWO

The mailing address of this corporation shall be: P.O. Box 2057, Palm Beach, Florida 33480.

ARTICLE THREE

The purpose for which the corporation is organized is that of a Cancer and AIDS information and data service, established and maintained, not for profit, but to provide information on cancer or cancer related to aids to:

1. Patients; to give them a general idea of what they are confronted with and what choices they have in regards to the treatment of their disease or
2. Physicians; Data directed towards the physician that far more direct in the treatment and result of a disease.
3. All or any interested parties for information on cancer stages and drugs being tested for the treatment of various cancers. Information can be located via my computer which is tied to the National Institutes of Healths Medlar computers which store up to date information on any type of cancer and the trials being carried out all over the country.

This data is then passed on to the inquiring party and a file shall be kept on the person so future inquiries can be updated.

ARTICLE FOUR

The manner in which the directors are elected or appointed is described in the by-laws of the corporation.

ARTICLE FIVE

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, with no limitations.

ARTICLE SIX
