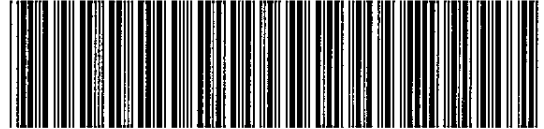

## ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

### Article I

The name of the corporation shall be: Triumph the Brotherhood Healing Temple Kingdom of God in Christ, Inc.

### Article II

#### Principal place of business and mailing address

The principal place of business and mailing address of this corporation shall be:

### Article III

#### Purpose(s)

Said Corporation is organized exclusively for religious and charitable purposes, including for such purposes, the making of distributions to organizations under Section 501©(3) of the Internal Revenue Code (or the corresponding section of any future Federal tax code. The church's purpose is worship and charitable outreach.

### Article IV

#### Manner of election of directors

The manner in which the directors are elected or appointed is as follows:  
Directors will be elected or appointed according to the bylaws of the organization. No part of the net earnings of the organization will inure to the benefit of or be distributable to its members, trustees, directors, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501©(3) purposes.

### Article V

#### Limitation of corporate powers

The corporate powers of this corporation (organization) are as provided in section 617.0302, Florida Statutes, unless limited as follows:

No substantial part of the activities of the corporation (organization) shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of these articles, the corporation (organization) shall not carry on any other activities not permitted to be carried on (a) by a corporation (organization) exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or (b) by a corporation (organization), contributions to which are deductible under Section 107(c)(2) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose.
