We, the undersigned persons of the State of Florida, all of whom are of legal age, each being copetent or contract, hereby form ourselves and our successors into a corporation not for profit under the laws of the State of Florida, and hereby adopt the following Articles of Incorporation.

ARTICLE I NAME

The name of this Corporation shall be: CENTRO DE ESTUDIOS CRISTIANOS, 1879 West Flagler St. Miami, Fl. 33135 wit its principal place of business located at Miami, County of Dade, Florida. ARTICLE II PURPOSE

ARTICLE III PROPERTY

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF CENTRO DE ESTUDIO CRISTIANOS, INC.

Pursuant to the provisions of Section 617.1006, Florida Statutes, the undersigned Florida Nonprofit Corporation adopts the following Articles of Incorporation.

FIRST: Article 1 - Name

The name is changed to CHNINO DE ESTUDIO CRISTIANOS, INC. OF MIAMI

Article II - Purpose of Corporation

Added: The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organization under section 501(c) (3) of the Internal Revenue, or the corresponding section of any future federal tax code.

Article III - Prohibitions

Added: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes setforth in Article Second hereof. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The President shall preside at all membership meetings. He shall by virtue of his office be Chairman of the Board of Directors. He shall present at each annual meeting of the organization an annual report of the work of the organization. He shall appoint all committees, temporary or permanent. He shall see all books, reports and certificates as required by law are properly kept or filed. He shall be one of the officers who may sign the checks or drafts of the organization.
