We, the undersigned, natural persons of the legal age, acting as incorporators of a non-profit corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be POWER HOUSE OF JESUS CHRIST, INC.

ARTICLE II

The principal place of business and the mailing address of this corporation shall be 19222 Ft. Dade Ave., Brooksville, FL 34601.

The period of duration of the corporation shall be perpetual.

ARTICLE III

The purposes for which this corporation is organized are:

The general nature and object of the corporation shall be the moral and mental improvement of men and women, the dissemination of the doctrine of the Christian religion; for the purpose of maintaining and conducting schools and classes for the

gratuitous instruction of men and women on the Bible, Bible literature, and Bible history; and to acquire, own, provide, and maintain places of worship and buildings for the gratuitous training of students, lectures, teachers, and ministers; and for the preaching and teaching of the religious doctrine of Christianity.

Any person shall be admitted to membership in the organization, who professes the Christian religion and agrees to comply with and abide by the By-Laws of this corporation after first having been baptized into the Christian faith.

ARTICLE IV

The number of directors of the corporation may be fixed by the by-laws, but shall not be less than three. Directors will be elected each year in accordance with the by-laws.

The number of directors constituting the initial board of directors shall be three (3) and the names and addresses of the persons who are to serve as directors are listed as follows:

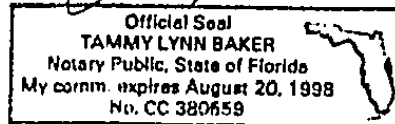
