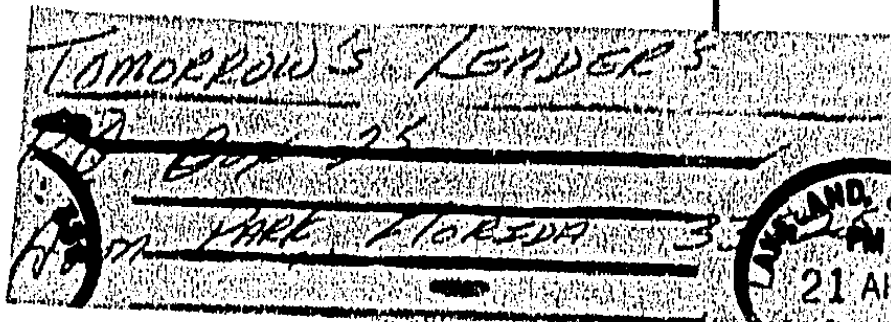

ARTICLES OF INCORPORATION
OF
TOMORROW'S LEADERS, Inc.

We, undersigned incorporators, hereby associate ourselves together to form and establish a corporation not for profit under the laws of the State of Florida.

FIRST: The name of the corporation is: Tomorrow's Leaders, Inc.

SECOND: The location of its principle place of business in the State is 100 East fourth street, Avon Park, Florida /mailing address P.O. 25 Avon Park, Florida.

THIRD: The ^{address} ~~name~~ of its registered office in this State is 100 East Fourth St. Avon Park Florida

FOURTH: The name and address of its resident agent in this State is 100 East Fourth St. Avon Park Florida, Linda Roberson.

FIFTH: This corporation is organized not for profit under Florida Statutes 617 and the objects and purposes to be transacted and carried on are to promote the general social welfare of the community and for that purpose:

to provide a place of positive learning and recreation;

to give young people, as well as parents, a sense of responsibility;

to unite the youth and community;

to acquire, improve, and operate any real or personal property or interest or right therein or appurtenant thereto;

to borrow money and to execute such evidence of indebtedness and such contracts, agreements, and instruments as may be necessary, and to execute and deliver any mortgage, deed or trust, therewith; and to do all things necessary and appropriate for carrying out and exercising the foregoing purposes and powers.

The purpose for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United State Internal law.

SIXTH: The number of directors shall be prescribed in the by-laws, but shall not be less than five.

SEVENTH: The corporation formed hereby shall have no capital stock. It shall be composed of members rather than shareholders. The conditions and regulations of membership and the rights or other privileges of the classes of members shall be determined

and fixed by the by-laws.

EIGHTH: The corporation formed hereby shall have no power to declare dividends. No part of its net earnings shall inure to the benefit of any member, director, or individual. the balance, if any, of all money received by the corporation from its operations, after payment in corporation of whatsoever kind and obligations of the corporation of whatsoever kind and nature as they become due shall be used to make advance payments on loans owned by the corporation, or for some related purpose.

TENTH: In the event of dissolution, the residual assets of the organization will be turned over to one or more organization which themselves are exempted as organizations described in sections 501(c) (3) and 170 (c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or the Federal, State, or local government for exclusive public purpose. In no event of dissolution thereof, go or be distributed to members, either for the reimbursement of any sum subscribed, donated, or contributed by such members or for any other purposes, provided that nothing shall prohibit the corporation from paying its just debts.

ELEVENTH: Members of the corporation shall not be liable for any debts or obligations of the corporation and shall not be subject to any assessment; but reasonable membership dues may be determined and fixed by the by-laws.

TWELFTH: The duration of the existence of this corporation shall be perpetual.

THIRTEENTH: these Articles of Incorporation may be amended at a special call meeting of the membership for that purpose by a majority vote of those present.

FOURTEEN: The directors will be elected at the annual meeting detail of elections are set up in the by-laws.

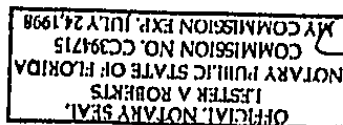
