ARTICLES OF INCORPORATION OF OLDSMAR FAMILY CENTER, INC. A NONPROFIT CORPORATION

We, the undersigned natural persons of legal age, at least two of whom are eitizens of the State of Florida, acting as incorporators of a corporation under Chapter 617 of the Florida Statutes, do hereby adopt the following articles of incorporation for such corporation:

ARTICLE - I NAME

The name of the corporation is the OLDSMAR FAMILY CENTER, INC.

ARTICLE II - DURATION

The duration of this corporation is perpetual unless dissolved according to law.

ARTICLE III - PURPOSE

The specific primary purposes for which the corporation is formed are to provide for the health, safety, and welfare of the citizens of the area as may hereafter be brought within the jurisdiction of the corporation for such purpose and for all other purposes allowed by law.

This corporation shall have and exercise all powers conferred upon not for profit corporations under the laws of the State of Florida generally, and specifically as provided in Section 617.021 of the Florida Not For Profit Corporation Act.

ARTICLE IV - REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered office of the association is 3711 Tampa Road, Suite 103, Oldsmar, Florida, County of Pinellas, and the name of its initial registered agent at such address is Bryan A. Kutchins.

ARTICLE V - FIRST BOARD OF DIRECTORS

The following five (5) persons shall serve the corporation as directors until the first annual meeting or other meeting called to elect directors:

ARTICLE VI - MANAGEMENT OF CORPORATE AFFAIRS

- (a) Board of Directors. The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of no less than five (5) directors and no more than fifteen (15) directors. The number of directors provided for in these Articles of Incorporation may be changed by a bylaw adopted by the board of directors.
- (b) Election of Directors. The method of electing directors shall be as set forth in the bylaws.
 - (c) Elective Officers. The officers of this corporation shall be a president, a

vice-president, a secretary, a treasurer and a parliamentarian. Other offices and officers may be established or appointed by the members of this corporation at any regular annual meeting or any special meeting of members called for such purpose. The qualifications, the time and manner of electing or appointing, the duties of, the terms of office, and the manner of removing officers shall be as set forth in the bylaws.

ARTICLE VII - BYLAWS

Bylaws will be hereafter adopted at the first meeting of the board of directors. Such bylaws may be amended, repealed, in whole or in part, by a majority vote of the members present, in the manner provided in the bylaws. Any amendments to the bylaws shall be binding on all members of this corporation.

ARTICLE VIII - AMENDMENT OF ARTICLES

Amendments to these articles of incorporation may be proposed by a resolution adopted by the board of directors and presented to a quorum of the present voting members for their vote. Amendments may be adopted by a vote of at least two-thirds of a quorum of the present and voting members of the corporation.

ARTICLE IX - DISTRIBUTION ON DISSOLUTION

Upon dissolution of this corporation all assets of the corporation shall be distributed to the Juvenile Welfare Board of Pinellas County.

ARTICLE X - INCORPORATORS
