### A NOT FOR PROFIT CORPORATION

The undersigned, acting as incorporator of a not for profit corporation pursuant to the provisions of Chapter 617 of the Florida Statutes, adopts the following Articles of Incorporation:

#### ARTICLE I. NAME

The name of the corporation shall be:
DRIVE SERVICE AND TRANSPORTERS ASSOCIATION OF FLORIDA, INC.

#### ARTICLE II. PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be:

402 Reo Street, Suite 118 Tampa, Florida 33609

#### ARTICLE\_III. PURPOSE

The corporation is organized to promote and advance the mutual interests of its members engaged in the drive service and transporter business; without limiting the generality of the foregoing, to associate its members together in such fashion that their united efforts in fostering the interests of the drive service and transporter business will result in tangible improvements inuring to their common good, betterment, and welfare; to root out disruptive and abusive practices in the industry and

other interrelated business; to define and set forth standards of ethical practices throughout the industry and evolve plans for compilance therewith by members and others; to devise means of securing, classifying and disseminating among its members trade, credit and other information vitally important in the conduct of the drive service and transporters business and their own enterprises; to eliminate unfair competition and unfair business practices in the drive services and transporters business; to foster exchange of ideas between its members; to hold meetings and provide discussion panels on various phases of the industry; and to have its members cooperate with each other in every possible way for the general welfare of one another.

Notwithstanding any other provision of these Articles, this corporation will not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under \$501(c) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in §501(c) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State or local government for exclusive public purpose.

#### ARTICLE IV. MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are to be elected or appointed is as stated in the Bylaws.

#### ARTICLE V. LIMITATION OF CORPORATION POWERS

The corporate powers of this corporation are as provided in \$671.0302, Florida Statutes.
