ARTICLES OF INCORPORATION FOR

SOUTH FLORIDA ENTERTAINMENT COA. TION, Inc.

The undersigned subscribers to these Articles of Incorporation natural persons competent to contract, hereby form a non-profit corporation under the State of Florida.

ARTICLE I

The name of the non-profit corporation is SOUTH FLORIDA ENTERTAINMENT COALITION, Inc.

ARTICLE II

The non-profit corporation shall exist perpetually. The corporate existence shall commence as of filing of the Articles of Incorporation with the Secretary of State.

ARTICLE III

The purpose of this organization is to promote, sponsor, and develop the appreciation, and education of the arts among the economically - disadvantaged, as well as the general public. In addition to, encouraging the patronage of the arts, producing artistic productions, exhibitions, and entertainments, and participating in activities that lawfully do any and all things necessary for providing educational and cultural training programs not for pecuniary gain within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE IV

Notwithstanding any other provision of those articles, this organization shall not carry on any activities not permitted to be carried on by an organization except from Federal Income Tax, under Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE V MEMBERSHIP

The qualifications of members and the manner of their admission are to be provided in the By-Laws of the Corporation.

ARTICLE VI BOARD DIRECTORS

INITIAL BOARD OF DIRECTORS

Directors of the Corporation shall be elected or removed in accordance with the procedures provided for in the By-Laws. The number constituting the initial Board of Directors of the Corporation is five (5) and the names and address of the persons who are to serve initially are as follows:

Upon the dissolution or winding up of this non-profit corporation, its assets remaining after payment, or provisions for payment of all debts and liabilities of the corporation, shall be distributed to a non-profit fund, foundation or corporation which is organized and operated exclusively for educational and cultural purposes and which has established its tax exempt status under Section 501(c)(3) of the internal Revenue Code of 1986 or corresponding provisions of any subsequent Federal income Tax Laws.

ARTICLE XI AMENDMENT

This non-profit corporation reserves the right to amend or repeal any prior provisions contained in the Articles of Incorporation or any amendment thereto. Amendments of these Articles of Incorporation may be proposed by a quorum of members for their vote. Amendments may be adopted by a quorum of members for their vote of 51% of a a quorum of members of the corporation.
