THE UNDERSIGNED, acting as the incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of this Corporation is MASTER'S PEACE MINISTRIES, INC.

ARTICLE II - DURATION

The duration of this Corporation is perpetual, unless dissolved according to law.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activity or business permitted under the laws of the United States and Florida. THIS IS A NOT FOR PROFIT CORPORATION. The purpose is to support Christian missionairies to aide the needs of the poor and needy, especially in Gutemala and Central America.

ARTICLE IV - PRINCIPAL OFFICE

That the principal office address of this Corporation shall be c/o Donald

Stewart White, 1101 East Ocean Boulevard, Stuart, Florida 34996, being the mailing address of this Corporation.

ARTICLE V - AMENDMENT

These Articles of Incorporation may be amended, altered, changed, or repealed by the affirmative vote of a majority of the members meeting called for that purpose.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VII - BOARD OF DIRECTORS




ARTICLE X - BY-LAWS




