**(A NON-PROFIT CORPORATION)**

*The undersigned, acting as Incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:*

## **ARTICLE I: NAME**

The name of the corporation shall be:

## **ARTICLE III: PURPOSE(S)**

The specific purpose(s) for which the corporation is organized is (are):

Said corporation is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law). No part of the net earning of the corporation shall leave to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in [these articles]. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not

participate in, or intervene (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any further United State Internal Law); or (b) by a corporation contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision for any future United States Internal Revenue Law).

## **ARTICLE IV: MANNER OF ELECTION OF DIRECTORS**

The manner in which the directors are elected or appointed is as follows:

The President of the corporation shall be Elder Charles Edward Weaver, II for the duration of the corporation, unless otherwise installed by the Presiding Jurisdictional Prelate of the Western Florida Jurisdiction, Church of God In Christ, Inc., according to the guidelines of the constitution of the Church Of God In Christ, Inc., National Headquarters located in the City of Memphis, Shelby County, Tennessee, or otherwise stated in the Bylaws of this corporation. The election and appointment of other directors shall be stated in the Bylaws of the corporation.

## **ARTICLE V: LIMITATION OF CORPORATE POWERS**

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:
