

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation shall be NEW BEGINNING MINISTRIES OF CENTRAL FLORIDA, INC.

The principal place of business of this corporation shall be 820 Chicago Avenue, Ocoee, Florida, 34761.

ARTICLE II

The period of the duration of this corporation is perpetual unless dissolved according to law.

ARTICLE III

The purpose or purpose for which the corporation is organized is to conduct the business of operating a church, conducting religious activities, operating a christian day school and engaging in any and all business permitted for churches under the laws of the State of Florida.

ARTICLE IV

The initial chairman of the board of trustees shall be:






