ARTICLES OF INCORPORATION OF

THE FOUNDATION FOR SOCIAL JUSTICE, INC. (A CORPORATION NOT FOR PROFIT)

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be The Foundation for Social Justice, Inc.

ARTICLE II

The purposes for which the corporation is organized are exclusively charitable, scientific, literary, educational, and the promotion of human and animal rights within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law.

Notwithstanding any other provision of these Articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law.

In the event of dissolution, the residual assets of the corporation will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code or to the Federal, State or local government for exclusive public purposes.

ARTICLE III

This corporation is to exist perpetually.

ARTICLE IV

The initial post office address of the principal office of this corporation in the State of Florida shall be 6850 Northwest 12th Avenue, Fort Lauderdale, FL 33309,. The Board of Directors may from time to time move the principal office to any other address in the State of Florida. The Registered Agent shall be

ARTICLE V

Qualification for membership and method of admission shall be as regulated by the By-Laws.

This corporation shall have not less than three directors; the number of directors may be increased from time to time by By-Laws adopted by the members of the corporation, but shall never be less than three, and shall be elected in accordance with the By-Laws.
