ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation pursuant of chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporations.

ARTICLE I - NAME

The name of the corporation shall be: Festival Independencia Centro American, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 52 Miracle Mile, Coral Gables, FL 33134.

The board of Directors may from time to time move the principal office to any other address in Florida.

ARTICLE III - PURPOSE(S)

The purposes for which the Corporation is organized are:

- a) The corporation shall operate exclusively for purposes beneficial to the community as a whole and the promotion of the State of Florida within the meaning and intent of the provisions of Section 501 (c) of the Internal Revenue Code and any subsequent amendments thereto.
- b) To represent with dignity and honor the Central American culture and beauty, so that citizens and visitors of our community shall become acquainted with, attracted to and interested in social, cultural, and educational aspects.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The manners in which directors are to be elected shall be stated in the by-laws.

ARTICLE V - LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes.

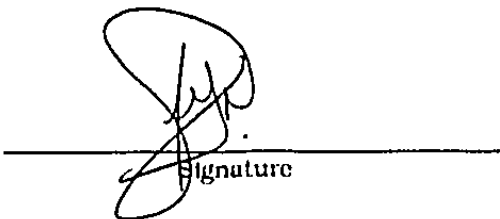

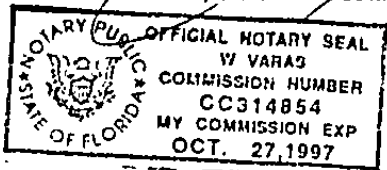

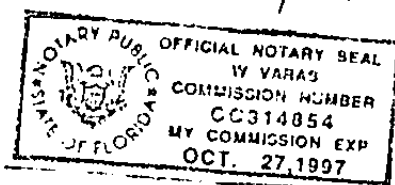
