THE UNDERSIGNED, hereby adopts these Articles of Incorporation pursuant to Section 617, Florida Statutes, as the Articles of Incorporation for Fisherman's Haven Homeowners Association, Inc.:

## ARTICLE I

The name of this corporation shall be Fisherman's Haven Homeowners Association, Inc..

#### ARTICLE II PURPOSE
